Welcome and Prayer

Alan Berry welcomed board members to the meeting. The meeting opened with a prayer led by lan.

Principal and Finance report

John Paul II High School - Principal report

Renée presented to the meeting her board report for John Paul II High School. Renée shared with the board about the literacy in high school going forward. There is on-going work to develop a schoolwide literacy across the curriculum approach to improve outcomes for students. This work is being spearheaded by the literacy navigator and her team.

John Paul II High School - Finance report

Renée presented to the meeting the financial report for July 2023. Note credit received for OCS for not completing a term clean. Liz and Renée attended a professional learning in school finance. Management report from the auditors, highlighted no issues. Graphic facilitation - raised with finance committee to have, accessible for the strategic plan, \$3000 for graphic plan how they would see. Helps to inform the strategic plan, three meters in size. Renée asked the board for approval on this as there are funds available and she would like to be able to confirm engagement with the facilitator.

St Patrick's School - Principal report

Ian presented to the meeting his board report for St Patrick's School. The year four annual religious education assessment has been completed. Mid year individual education plans (IEP) reviews have been completed.Following the previous Board meeting the St Patrick's graduate profile has been circulated to stakeholders. Feedback will be incorporated into the final document. Number of incidents have steadily declined since May, with only 35 in July. Presently Thursday is our worst day for incidents- events increase over the week but this is less than last year. A further positive takeaway is there is a clear dip on Friday's currently- this may be due to Octoball and whanau time. 1.10pm -3.00pm is when most behaviour occurs with the classrooms and the field being our hotspots.

Special Issue

Dedicated board

Prior to the meeting a document was shared with all board members in relation to a dedicated board. This document outlined next steps and questions from the Bishop. The Bishop's letter to board December 2022 stated he requires the current Greymouth Catholic Schools' Board to address, and or confirm its acceptance of the following matters, before he will be in a position to contemplate providing the proprietorial approval to proceed to a formal community consultation in this matter.

- 1. He requires each of the two schools to have four proprietor appointees, and this means that each school must have five elected parent trustees, as well as the Principal and staff trustees (plus a student trustee for John Paul II High School)
- 2. We (the bot) rightly note there must be a detailed consultation with the Catholic Education Office regarding the development of a binding memorandum between the Bishop and the two separate school boards as to how property is to be addressed by staff and students of the two separate schools and which areas are to be maintained by the two separate schools this is required as property provision has previously been provided by the Bishop to one governing body for both schools and common areas such as the staffroom, library, hall and Civic centre are able to be accessed by staff and students of both schools; albeit these areas technically reside on the 'books' of one school or the other. This matter must be satisfactorily confirmed, in order to enshrine fairness and equity, before any community consultation is contemplated and/or undertaken. As this is a local community decision to explore two separate bodies, in the first instance the Bishop requires the Greymouth Catholic Schools' Board to turn its mind to how two separate school boards would agree in perpetuity to grant mutual access, and how each of the two school boards would agree in perpetuity to provide an agreed contribution to the maintenance of shared 'common' property areas.
- 3. How would two separate school boards enhance the likely flow of students from St Patrick's School to John Paul II High School.

Moved Alan Berry / Miles Roper "that the board agree to both schools to have four proprietor appointees, and this means that each school must have five elected parent trustees, as well as the Principal and staff trustees (plus a student trustee for John Paul II High School)".

The Greymouth Catholic Schools' Board of Trustees humbly request your consideration of this matter and your guidance on the steps forward. To be added to the letter is an invitation for the Bishop to meet with our board of trustees in relation to this letter, with the board offering for the Bishop to come to us or a delegation of our board can go to the Bishop.

Well being survey

The well being survey has been shared with staff at both John Paul II High School and St Patrick's School. Close off for this survey is Friday 15 September 2023 at midday. The board is to seek guidance from NZSTA as to how to share the results with the staff of both schools. This is a confidential survey with no links to be able to identify staff, no collection of email addresses or names. Planning to be able to report back to the board at the October board meeting.

Community consultation re JPIIHS head students

Data from the student leadership survey. This was live for 14 days, available through two newsletters, and emailed directly to students and parents. There were 133 responses: 70 (students), 42 (parents), 16 (staff members), 5 (Parishioners). Suitability for the role was ranked the highest attribute for leadership, whilst gender and strong Catholic values the lowest ranked attributes. 'Contribute to the collective good of the school, students, and JPII community' was ranked first as the main purpose of student leadership. 'Serve the status of the individual leader' was ranked the lowest. 'Collaboration and student voice in the school' was the highest ranked benefit of student leadership. 'Gaining tertiary scholarships' and 'gaining insight into the running of an organization' the lowest ranked benefits. The servant leadership model was selected as the preferred model of student leadership. The the traditional colonial (hierarchical) model was ranked lowest. There were 91 written responses to the question 'What do you think student leadership roles are for? What sorts of things do you think student leaders do or should do at JPII?' To be a voice for students was the most common response. A steering group is working together on what the next steps will be. Renée advised the meeting she will have further information to share at the next board meeting. Report on student leadership survey for John Paul II High School.
